

FOSTER AGREEMENT

CONDITIONS *(Please turn over for definitions and explanations to conditions set out below)*

1. The custodian agrees to keep fostered at the above address all greyhounds agreed by Greyhound Racing SA and the Greyhound Adoption Program and the custodian as the subjects of fostering by the custodian.
2. If the greyhound becomes ill, the custodian will immediately report to Greyhound Adoption Program, and if required deliver the dog for inspection or veterinary service.
3. The custodian will, at the custodians cost, look after the greyhounds and provide the greyhounds with water, shelter, exercise, health care, and reasonable treatment, and carry out all instruction relating to the debriefing of the greyhounds as requested by the coordinators of the Program, and upon request, will deliver the greyhounds in good order to the Greyhound Adoption Program. The Program will make available to the custodian, at the Programs cost, reasonable food requirements for the benefit of the greyhound.
4. The custodian will permit the coordinator (or authorized agent thereof of the Program) to inspect any fostering greyhound at any time, should this be requested.
5. If, despite reasonable care, the fostering greyhound becomes lost, no liability will be attached to the custodian. However, the incident shall be immediately reported to the coordinator and all reasonable steps for its recovery should be commenced promptly by the custodian at its cost.
6. The custodian agrees that the greyhounds will not be sued for experimental or research purposes of any description, and that the custodian is not a dealer or an agent of a dealer.
7. The Greyhound Adoption Program reserves the right to terminate this agreement at any time, by written notice to the custodian in which case the custodian agrees to deliver the greyhounds to the Program's nominee.
8. The custodian will take full responsibility for the greyhounds, including responsibility for any damage or injury caused by a greyhound while it is in the care or premises of the custodian. The custodian will indemnify the Program and Greyhound Racing SA for any costs or expenses incurred by them relating to any greyhound while it is in the custodians care or possession.
9. The custodian understand that all equipment supplied to the foster home is the property of the Greyhound Adoption Program and must be returned if this agreement is terminated.
10. The custodian will ensure that at any time any greyhound is taken into a public place it will always be appropriately leashed and controlled by the custodian or a person authorized by the custodian.
11. The custodian will never have more than two greyhounds under his/her control when those greyhounds are taken into public places.
12. The custodian agrees to complete and submit the necessary "Foster Summary" and any other documents requested by the Program.

Definitions to Agreement:

Custodian: The person who is the foster carer for greyhounds as part of the Program.

Program: Greyhound Adoption Program.

Health Care: This pertains to condition 3 of the Foster Agreement. By health care this means for the general health and well being for the greyhound. This **does not** include costs incurred for general veterinary expenses.
Clause 3.

Indemnify: This means that the custodian will pay any costs incurred for damages to any property and equipment supplied that are owned by the Greyhound Adoption Program and Greyhound Racing SA, when requested.
Clause 8.

PLEASE NOTE:

The Greyhound Adoption Program will supply all necessary equipment and food for any Greyhound on the program. It is rare for any custodian to be requested to pay any indemnity or veterinary expenses.

The Greyhound Adoption Program SA is a non-profit organization who is thankful for the assistance by volunteers that do valuable work to help the cause. As part their valued help Custodians receive a small fee during the time(s) they are caring for greyhounds as part of the Program.
